All memberships are valid from April 1<sup>st</sup> to the following March 31<sup>st</sup> in a given year. **If you desire a payment plan; 1<sup>st</sup> payment of 10% down plus initiation fee (if applicable) is due by April 1<sup>st</sup>.** New members only, may join later in the year at a prorated amount of full membership divided by Ten. A 3% interest charge is charged to your account at the beginning of every month on the previous balance minus payments received. **Interest on your "Membership Only" begins May 1<sup>st</sup>.** Your account is treated as a revolving account for charges and payments at Valley View. All members are eligible for a revolving account, which is set up automatically unless the club is specifically asked not to. This is a personal account and does not effect your "credit history" unless turned in to a collection agency. All information is private and kept on record. If a payment is more than sixty days past due and you do not respond to attempts to contact you or you do not contact us, your account may be turned over to a collection agency and/or continue to be charged the 3% interest rate as stated herein. Please don't let this happen. We want to keep you in good standing and communication is the key to a working relationship.

A maximum credit line may be initiated by Valley View according to individual account types unless otherwise arranged. Accounts are expected to be **paid in full by February 28th, 2012.** Valley View reserves the right to put holds on account credit. Valley View reserves the right to reject an application and/or to deny a credit account for any reason.

An account may be cancelled anytime during the year due to "willful violation" of club rules, poor etiquette practices, regulations, blatant disregard for personal or golf course property, Early termination does not guarantee a return of prorated membership fees and will be considered on an individual basis. "Willful violation:" is cause for a non-refundable cancellation of membership.
